The Dublin Journal Saturday 19 October 1745.

Whereas from the present Stagnation in Trade, occasioned by the Commotions at this Time in Scotland, many weak minded and ignorant People may be dissident of the Public Credits of this Kingdom, and thereby obstruct the Commerce thereof and injure his Majesty's Revenue.

Now, We the undernamed Merchants, and others hereunder subscribing. being convinced of our Safety in the present Banks of -

Messrs Swift and Company, Messrs Latouch, Kane and Latouch, Messrs Fade and Wilcocks, Mr William Lennox, Messrs Richard and Thomas Dawson, and Messrs Mitchell and Macarell -

Do in regard to the Public hereby declare, That we will accept of any of the said Banker's Notes as Cash in all Payments, Receipts whatsoever and that we will stand by and support Public Credit in all Respects to the utmost of our Power, being convinced that any Obstruction thereto would at this Juncture occasion the greatest Confusion, and distress those who are willing to support our present happy Establishment: Townley Ahmuty

Morning Post & Daily Advertiser Wednesday 30 December 1778. On the 12th inst. died in Meath Street, Dublin at an advanced age, Townley Ahmuty Esq many years a merchant of considerable eminence and distinguished integrity.

Townley Ahmuty a brother of Thomas Ahmuty married **Alicia Hale** the daughter of Richard Hale by licence dated 7 June 1786 at St Catherine's Church, Dublin. In 1788 he was a Caveator in the adjudication of the Will of Helen Auchmuty the daughter of John Auchmuty and Isabel Stirling; she had married Toby Dodd whose brother James Dodd had married her sister Martha

If therefore there appear not any let, suit or impediment of or by reason of any affinity, consanguinity, pre-contract or otherwise that may hinder the said marriage; also if there be not any suit or controversy had, moved or depending before any judge, ecclesiastical or civil, for or concerning the said marriage, or contract of either the said parties without any other; further that the said parties do not proceed to the solemnization of the said marriage without the consent of parents, guardians or tutors (if any they have) be thereunto first had and obtained. If therefore there appear not any let, suit or impediment of or by reason of any affinity, consanguinity, pre-contract or otherwise that may hinder the said marriage; also if there be not any suit or controversy had, moved or depending before any judge, ecclesiastical or civil, for or concerning the said marriage, or contract of either the said parties without any other; and further, that the said parties do not proceed to the solemnization of the said marriage without the consent of parents, guardians or tutors (if any they have) be thereunto first had and obtained. Thomas Auchmuty -1712

Thomas Auchmuty the son of Arthur Auchmuty and Elizabeth Rynd married Dorcas Townley the daughter of Samuel Townley of co Cavan and died 13 March 1712 leaving five sons Samuel, John, Thomas, Townley and Arthur who variously had the surnames of Auchmuty, Achmuty or Ahmuty

In 1714 his widow Dorcas Auchmuty as sole executrix drew up an **Accompt** which listed all the payments, expenses and charges that had been incurred administering her late husband's estate

Dorcas Auchmuty later remarried and her second husband was James Lawder of Kilmore, co Roscommon whose brother William Lawder of Bonnybeg married Catherine Auchmuty the sister of Arthur Auchmuty -1696 who had married Elizabeth Rynd in 1669

An **Indenture** dated 1 May 1696 was drawn up between Arthur Auchmuty and others regarding the yearly rent of land in Lower Kilmore in the Barony of Longford
