Ann Ahmuty - application for a Widow's Pension 1805

DRIVER

This deponent **Ann Ahmuty** widow of **Arthur Ahmuty** late Surgeon of His Majesty's Sloop the *Dorien*? who died 11th day of May 1804 maketh oath that she is not possessed of a clear annual income to the amount of £20 and that she was legally married to the said **Arthur Ahmuty** on the 31st day of December 1798 in the parish church of Minster in Sheppy in the county of Kent in or about the 33rd year of his age; and she further maketh oath that she has not since been married to any other person whatsoever. (signed)

Sworn before me this 9th day of September 1805 at Deale in the county of Kent (signed) Milloy? a Justice of Peace

These are to certify the Court of Assistants for managing the Charity for Relief of Poor Widows of Commission and Warrant Officers of the Royal Navy that **Arthur Ahmuty** late Surgeon of His Majesty's Sloop the *Dorien*? died on the 11th day of May 1804 and has left the bearer **Ann Ahmuty** a widow; and according to the best information I can get from others and do really believe my self that she is not possessed of a clear annual income to the value of £20 and therefore she appears to me to be intitled to the benefit of the said Charity under their direction. Dated at His Majesty's Yard at Deale this 9th day of September 1805. (signed) Geo. Lawrance Naval Officer

This deponent **Ann Ahmuty** voluntarily maketh oath that she continues still the widow of **Arthur Ahmuty** having never since been married to any other person; and that her circumstance, in point of fortune, remains confined within the limitation authorized by His Majesty's Sign Manual bearing date the 18th of October 1805 respecting the Charity established for the Relief of the Widows of Commission and Warrant Officers of the Navy, which directs that the widow of a surgeon shall be allowed a pension of £40 per annum, provided her income otherwise arising does not amount to double the sum allowed for her said pension. Sworn this 17th day of May 1806 before me at Deale in the county of Kent (signed) Thos. Shipdem Mayor

Mr **Arthur Ahmuty** late a Surgeon in the Royal Navy has paid the usual allowance of three pence per pound toward the payment of Widows Pensions. (signed) Geo. ? dated at the Navy Office the 21st May 1806

Mr **Arthur Ahmuty** was placed on the list of Naval Surgeons on the 10th October 1796 and remained there on the 11th May 1804 when he is stated to have died; he was not at the time employed. (signed) John Mossman? Transport Officer 5th July 1806
