William Lewis received £30 estate on death of his mother, his annuity reduced to £20 p.a.

The Rev John Lewis, Dean of Ossory in his Will dated 10 February 1778 bequeathed his wife Charlotte his house in the Royal Crescent of Bath provided she paid the annuity devised by Joseph Lewis to his nephew William Lewis.

Declaration by all the interested parties by Indenture of even date 19 December 1783

The transfer of £25 Long Annuities from Charlotte Lewis widow of Bath to Jasper Sabine esq of Bath and George Smith banker of George Street, Mansion House London in trust to pay £20 p.a. to William Lewis for life.
