We all & singular the Faithful in Christ to whom these presents & come Eternal Salvation in the Lord, know that I George of Granard & Viscount Forbess & Baron of Clanhugh being assured of the exemplary life & virtuous morals of **Samuel A'hmuty** Clerk Master of Arts & moreover being firmly persuaded of his knowledge in the Holy Scriptures, Fidelity to the King & Pious regard for the church do nominate, admit, constitute & appoint the said **Samuel A'hmuty my Domestic Chaplain** that he may justly possess & enjoy all & singular the Rights, Priviledges, Preeminences & Immunities which by Acts of Parliament have been granted & confirmed to the Chaplains of Earls & Peers of the Kingdom of Ireland.

In testimony whereof I sign these presents with my Hand & Seal them with my Coat of Arms. Given in my House of Castle Forbes this **thirteenth Day of June 1770** seventy, & in the Tenth year of the Reign of his Majesty King George the Third by the Grace of God of Great Britain &

Draft Memorial of Settlement on the Intermarriage of the Rev'd Samuel Ahmuty with Miss M C Lyons

2 APRIL 1806

To the Registrar appointed by Act of Parliament for registering Deeds, Conveyances and so forth.

A memorial of an indented Deed of Release bearing date the 2nd day of April 1806 and made or mentioned to be made between the **Rev'd Samuel Ahmuty of Ballymuloy in the county of Longford, clke, of the 1st part, Caroline Lyons orwise Degennes, widow of John Lyons late of Ladystown in the co. of W. Meath, esq. and Margaret Christina Lyons, spinster, eldest daughter then living of the s'd Caroline and John Lyons of the 2nd pt. and Samuel Ahmuty of Brianstown in the co. of Longford, esq. Lieut. Col. in his Majestys Regiment of Royal Longford Militia and Thomas Tenison of Castle Tenison in the co. of Roscommon, esq. of the 3rd pt.**

Whereby after reciting as therein is recited, the s'd **Rev'd Samuel Ahmuty** for and in consideration of a marriage there intended to be had between him and the s'd **Margaret Christina Lyons** and for and in consideration of the portion and fortune of the s'd **Margaret Christina Lyons** to be settled as thereafter mentioned and for and in consideration of the sum of 10.7 sterling to him in hand paid by the s'd **Lieut. Col. Samuel Ahmuty and Thomas. Tenison** and for other considerations paid thereunto to moving. Did grant, bargain, sell alien release and confirm unto the s'd **Lieut. Col. Samuel Ahmuty and Thomas Tenison** (in their actual possession then being by virute of a lease for a year therein recited) and to their heirs, executors, and administrators

All that and those the moiety of the town and lands of **Cloonark** formerly in the possession of **George Deane, Michael Cox** and others situate in the Barony and co. of Longford in and by the 1st therein recited Indenture granted and demised by **Samuel Ahmuty (the elder)** therein mentioned to **Samuel Ahmuty the younger, father of the Rev'd Samuel Ahmuty party thereto**

And also all that and those the town and lands of **Baleagh** as it was formerly held by **Denis Gorttany and Partners** situate in the Barony and co. of Longford in and by the 2nd therein recited Indenture granted and demised by the s'd **Samuel Ahmuty (the elder)** to the s'd **Samuel Ahmuty the younger, father of the Rev'd Samuel Ahmuty party thereto**

And also all that and those the town and lands of **Cloonin with the Islands** thus made belonging in full and ample manner as they were formerly held and enjoyed by **Darby Cox and Partners** situate in the Barony and co. of Longford in and by the 3rd therein recited Indenture granted and demised by the s'd **Samuel Ahmuty the elder** to the s'd **Samuel Ahmuty the younger, father of the Rev'd Samuel Ahmuty party thereto**

And also all that and those the **Island of Derrynacrutt** in as full and ample a manner as lately held by **Thomas Hanly** situate in the co. of Longford in and by the 4th therein recited Indenture granted and demised by the s'd **Lieut. Col. Ahmuty party thereto to Christopher Robinson** therein mentioned and by him assigned to the s'd **Samuel Ahmuty dec'd, father of the Rev'd Samuel Ahmuty party thereto**

And also all that and those the town and lands of **Anaghmore** containing by a survey lately made thereof 42 - 3 and 23 of arable and pasture ground with 147 - 2 and 21 of bog making in the whole 190 - 2 and 4 be the same more or less situate in the parish of **Killashee, Barony of Moydow** and co. of Longford in and by the 5th therein recited Indenture granted and demised by the **Right Honourable George, Earl of Granard** to the s'd **Samuel Ahmuty dec'd, father of the Rev'd Samuel Ahmuty, party thereto**

And also all that and those the town and lands of **Lower Kilmore** containing 131 and 37 of arable and pasture lands and 94 and 18 of mountain and bog making in the whole 225 - 1 and 15 measure be them same more or less situate in the Barony and co. of Longford in and by the 6th therein recited Indenture granted and demised by the s'd **George, Earl of Granard** to the s'd **Samuel Ahmuty dec'd, father of the Rev'd Samuel Ahmuty part thereto**

And also all that and those that part of the town and lands of **Ardneorany** formerly in the possession of **Edward Gearty** containing 17 - 3 and 25 or thereabouts be the same more or less situate in the parish of **Noughavill, Barony of Kilkenny West** and co. of **W. Meath** in and by the 7th therein recited Indenture granted and demised by the **Rev'd Thomas Jessop, Dr. of Laws** to the said **Samuel Ahmuty dec'd, father of the Rev'd Samuel Ahmuty, party thereto** and the renewal thereof as therein mentioned

And also all that and those that part of **Barnecorr** called **Belaneere** containing by **Mulvihills Survey 78 - 3** and **20** be the same more or less situate in the parish of **Shruel Barony of Ratheline** and co. of **Longford** in and by the **8th** and last therein recited Indenture granted and demised by **William and David Murray** to the **Rev'd Samuel Ahmuty** party thereto.

To hold together all the s'd premises with their appurtenances together with the s'd ? therein in ? recited Indentures, except the town and lands of **Ardneorany** unto the s'd **Lieut. Col. Samuel Ahmuty** and **Thomas Tenison** their heirs, ex'ors, administrators and assigns for and during the respective life and lives of the several persons respectively named as ? ? in and by th s'd therein recited Indentures who were then in being and for and during the remainder of such term of years in s'd Indentures respectively mentioned as should be to come and unexpired (if any) after the expiration of the lives therein respectively mentioned in as full and ample a manner as the s'd **Rev'd Samuel Ahmuty** then held and enjoyed the same.

And to hold s'd town and lands of **Ardneorany** with therein appurtenances unto the s'd **Lieut. Col. Samuel Ahmuty** and **Thomas Tenison** their heirs and assigns for the 3 lives therein mentioned and for and during the such life and lives as should for ever thereof be added to the term granted by the **7th** therewith recited Indenture by virtue of the Codicils for perpetual renewal therein contained Subject however to the respective rents and covenants contained in s'd respective recited Indentures on the tenant or leasees part to be paid, done and performed Upon the trusts nevertheless and to and for the uses, intents and purposes therein expressed and declared of and concerning the same

And whereby in consideration of s'd intended marriage and of the provisions therein made and to be made by the s'd **Rev'd Samuel Ahmuty** for the children of s'd intended marriage, and in consideration of **10.?** sterling to each of them, the s'd **Caroline Lyons** orwise **Degennes** and the s'd **Margaret Christina Lyons** respectively in hand paid by the s'd **Lieut. Col. Samuel Ahmuty** and **Thomas Tenison** and for divers other good considerations him moving thereunto she the s'd **Margaret Christina Lyons** by and with the consent of the s'd **Rev'd Samuel Ahmuty** and her mother the s'd **Caroline Lyons** testified as therein mentioned

Did grant, assign, transfer and make over unto the s'd **Lieut. Col. Samuel Ahmuty** and **Thomas Tenison** All that the sum of **£750** sterling being the proportion or share of the sum of **£3000** settled by the Deeds of Lease and Release of the **24th** and **25th** of May 1705 therein recited for the portions of the younger children and the s'd **John Lyons** by the s'd **Caroline Lyons** which the s'd **Margaret Christina Lyons** as one of the s'd younger children was entitled, charged and chargeable on the several towns, lands, tenements, hereditaments and freeholds in s'd deeds mentioned with all interest due and to grow due thereon.

And also all that proportion or share of the two Bonds of **John Daniel Degennes**, esq to the s'd **John Lyons** for the sum of **£1000** cash chargeable on the farm of **Koragonogorly** in the co. of **Meath** being one third thereof and amounting to the sum of **£606.13.4** to which the s'd **Margaret Christina Lyons** was intitled by the last Will and Testament of s'd **John Lyons** as one of his 3 younger children who survived him together with interest for the same.

To hold receive and take the s'd several sums together with all Indentures due and to grow due thereon respectively unto the s'd **Lieut. Col. Samuel Ahmuty** and **Thos. Tenison** and the survivors of them and the ex'ors, adm'ors and assigns of such survivor Upon the Trusts nevertheless and to and for the uses, intents and purposes therein expressed and declared of and concerning the same And whereby for the considerations afores'd she the s'd **Margaret Christina Lyons** and with the consent of the **Rev'd Samuel Ahmuty** and of her s'd mother testified as therein mentioned Did grant, bargain, sell alien release and confirm unto the s'd **Lieut. Col. Samuel Ahmuty** and **Thos. Tenison** in their actual ? then being by virtue of a lease for a year therein recited and to their heirs and assigns

All that the reversionary interest of the s'd **Margaret Christina Lyons** of and in the one fourth part of the property of her **Grand uncle Renè David Degennes** placed in the Funds of England as therein mentioned expectant on the death of her s'd mother And also all that the reversionary interest of the s'd **Margaret Christina Lyons** of and in the one fourth part of the property of her **Grand aunt Anne Maria Degennes** placed likewise in s'd Funds also expectant on the death of her s'd mother.

To hold receive and take the s'd shares and proportions and interest of the s'd **Margaret Christina Lyons** unto the s'd **Lieut. Col. Samuel Ahmuty and Thos. Tenison** and the survivor of them and the ex'ors, adm'ors and assigns of such survivor from the day of the death of the s'd **Caroline Lyons** mother of the s'd **Margaret Christiana Lyons** Upon the Trusts nevertheless and to and upon the uses, intents and purposes therein mentioned expressed and declared of concerning the same

And whereby for the consideration afores'd she the s'd **Margaret Christina Lyons** with the consent of the s'd **Rev'd Samuel Ahmuty** and of her s'd mother testified as therein mentioned Did grant, bargain, sell alien release and confirm unto the s'd **Lieut. Col. Samuel Ahmuty and Thos. Tenison** All the share estates right, title, interest, property claim and demand of her the s'd **Margaret Christina Lyons** (expectant on the death of her mother the s'd **Caroline Lyons** equally to be divided between the issue of the s'd **Caroline Lyons** which shall be then living) of in and to the **freehold farm of Knogonogooly situate in the co. of Meath** and to which she is entitled on the contingency afores'd by virtue of the Will of the s'd **John Daniel Degennes** subject however to the incumbents therein mentioned to be affecting the same, and the rent clauses and rent fines by the original lease and renewals thereof reserved and made pay thereout

To hold s'd reversionary share estate or interest in s'd freehold farm with the appurtenances unto the s'd **Lieut. Col. Samuel Ahmuty and Thos. Tenison** their heirs and assigns for and during the life and lives in the renewal thereof which shall be in being at the time of the death of the s'd **Caroline Lyons** and for and during the life and lives which shall for ever thereafter be added thereto by virtue of the codicils for perpetual renewal in the original lease thereof contained Upon the Trusts nevertheless and to and upon the uses, intents and purposes therein mentioned, expressed and declared of and concerning the same which s'd deed -

Know that all Men by these presents that we Samuel Ahmuty, Ballymulvey, Co. Longford, Clerk, and Robert Forbes Ahmuty of the City of Dublin, Gent, Attorney at Law are holden and firmly bound by the Most Reverend Father in God Charles by Divine Providence, Lord Archbishop of Dublin, Primate and Metropolitan of Ireland in the sum of one thousand pounds of good and lawful money of great britain, to be paid to the said most reverend father in god charles or his certain attorney, executors, administrators, or assigns for which payment well and truly to be made we bind ourselves and each of us for the whole, our heirs, executors and administrators, firmly by these presents. sealed with our seals dated the 8th day of april in the year of our lord one thousand eight hundred and six. Samuel Ahmuty and Margaret Christina Lyons of the Parish of St. Mark, spinster. signed Samuel Ahmuty. Arthur Samuels. Robert Forbes Ahmuty

The condition of the above Obligation is such, that whereas licence is granted to solemnise matrimony between the above-bounden Samuel Ahmuty and Margaret Christina Lyons of the Parish of St. Mark, Spinster. If therefore there appear not any Let, Suit or Impediment, or by reason of any affinity, Consanguinity, Pre-Contract, or otherwise, that may hinder the said marriage : Also if there be not any suit or controversy, had, moved or depending before any Judge, Ecclesiastical or Civil for or concerning the said Marriage, or Contract, of either the said Parties with any other: And further, that the said Parties do not proceed to the Solemnisation of the said Marriage without the Consent of Parents, Guardians or Tutors (if any they have) be thereunto first had and obtained. That then this obligation to be void, or else to remain in full Force, by Virtue in Law.
