

This is the last Will and Testament of me **Henry Rigby** of the city of New Sarum in the county of Wilts clerk made and published the 3rd day of November in the year of our Lord 1817 as follows I will and direct that all my just debts funeral and testamentary charges be paid and satisfied as soon as conveniently can be after my decease

I give and devise to **Anthony Mervin Reeve Storey** of the Middle Temple London esquire to **Peter Templeman** of Whichbury in the said county of Wilts esquire and **Thomas Andrews** of Ludgate Street London linen draper their heirs executors administrators and assigns all that my freehold messuage or dwelling house garden coach house and stable with their and every of their appurtenances situate in Crane Street in the said city of New Sarum and also all that my leasehold messuage farm lands and hereditaments at Ockford Fitzpain in the county of Dorset and also all that my leasehold farm lands and hereditaments at Bradford Abbas in the said county of Dorset with their and every of their appurtenances and all other my real estate whatsoever and wheresoever To have and to hold all and singular the aforesaid premises to the said **Anthony Mervin Reeve Storey Peter Templeman and Thomas Andrews** their heirs executors administrators and assigns according to the nature and quality thereof respectively upon and for the trusts intents and purposes hereinafter declared concerning the same (that is to say)

Upon trust to permit and suffer **Fanny my wife** and her assigns peaceably to occupy possess and enjoy all and singular the aforesaid premises and to receive and take the rents issues and profits thereof for her own use during her life and after her decease Upon trust to sell and dispose of the same premises respectively for the best price or prices that can be obtained for the same and I will and direct that the money to arise from the sale of the said premises shall be deemed and taken to be part of my personal and be subject to the same trusts as are hereinafter declared concerning the same

and I give and bequeath to the said **Anthony Mervin Reeve Storey Peter Templeman and Thomas Andrews** their executors administrators and assigns all my stock in the public funds moneys securities for money and all my goods chattels and other my personal estate and effects whatsoever To hold the same respectively to the said **Anthony Mervin Reeve Storey Peter Templeman and Thomas Andrews** their executors administrators and assigns upon and for the several trusts hereinafter declared concerning the same that is to say

Upon trust to pay out of the dividends and interest thereof to my said wife and her assigns during her life a clear annuity or yearly sum of £400 free from all deductions and outgoings whatsoever by two equal half yearly payments in every year namely on the first day of February and the first day of August the first payment to be made on such of the said days as shall happen next after my decease And also upon trust to pay to the executors administrators or assigns of my said wife such a proportionable part of the said annuity or clear yearly sum of £400 as at the time of her decease shall have elapsed since the preceding half yearly day of payment

and also upon trust from and after my decease to raise a future annuity or yearly sum of £200 and to pay apply and dispose of the same for and towards the education support maintenance apprenticing or putting out of the four sons respectively of my nephew **George Arrowsmith** namely **George Arrowsmith** aged about 17 years **Joseph Arrowsmith** aged about 15 years **Henry Abel Arrowsmith** aged about 13 years and **Charles Arrowsmith** aged about 11 years to some trades professions business or employment and for setting them up therein or for their advancement the same to be applied in such shares or proportions and in such manner and form as my said trustees for the time being or the majority of them shall from time to time think proper and to be done at the entire discretion of my said trustees without the interference or control of the said **George Arrowsmith** or of any other person or persons whomsoever

and in case there at any time be any overplus of the said annuity or yearly sum of £200 after providing for the said four children then to pay such overplus to my said nephew **George Arrowsmith** for his own use and so from time to time until all the said children shall be provided for according to the trust and intent aforesaid and when all the said children of the said **George Arrowsmith** shall have been provided for in manner aforesaid then upon trust to pay the whole of the said annuity or yearly sum of £200 to the said **George Arrowsmith** during his life for his own use and benefit and upon trust from and after the decease of the said **George Arrowsmith** to pay the said annuity or yearly sum of £200 to and amongst the said four children of the said **George Arrowsmith** equally share and share alike during their respective lives and to the survivors and survivor of them during their lives and his life as Tenants in Common provided always that if the said **George Arrowsmith** shall assign or allocate the said annuity or yearly sum of £200 or do any act whereby the same may be charged or incumbered I will and direct that from thereof the said annuity or yearly sum shall cease and be no longer payable to him as his assignee or incumbrancer but the same shall from thereof be paid to and amongst his said four children during their lives equally share and share alike and to the survivors and survivor of them during their lives or his life as Tenants in Common as if the said **George Arrowsmith** were actually dead

and upon further trust after the decease of **Fanny my said wife** and subject to the payment of her said annuity of £400 for her life to stand possessed of £4,000 stock in the 5 per cents part of my present stock in the funds and to

pay the dividends and annual interest thereof to my sister in law **Mary Anne Rigby** widow of my brother **Tipping Rigby** late an Alderman of London and her assigns for her life and from and immediately after her decease upon trust to sell and transfer the said £4,000 stock and to divide and pay the produce arising from such sale between and amongst all her children equally share and share alike as Tenants in Common and if any or either of her children shall happen to die in her lifetime leaving issue who shall be living at her decease upon trust to pay the part or share of each such child so dying to his her or their issue or the executors or administrators of such issue

and also upon trust after the decease of my said wife and subject to the payment of her said annuity for her life to stand possessed of the further sum of £4,000 stock in the 5 per cents being also part of my present stock in the funds and to pay the dividends and annual interest thereof to my niece **Sarah Anne Cotton** daughter of my late brother **George Rigby** and wife of **Thomas Cotton** of Enfield in the county of Middlesex esquire for her life the same to be paid into her own hands or to such person or persons as she whether covert or sole shall by any writing under her hand from time to time appoint to the intent that the same may be for her separate use and not subject to the debts control or interference of her present or any future husband and that the receipt and receipts of the said **Sarah Anne Cotton** for the said dividends or of the person or persons whom she shall appoint to receive the same shall whether she be covert or sole be an effectual discharge or effectual discharges for the money therein mentioned and acknowledged to be received

and also upon trust as to my pictures and prints and to all my wines and other liquors to permit my said wife to take the same for her own use and also upon trust as to my household furniture plate linen china and books to permit my said wife to have the use and enjoyment of the same during her life and after her decease upon trust for the person who shall be entitled under this my Will to the residue of my personal estate and upon trust to pay to my nephew the **Rev Christopher Rigby Collins** 5 guineas for a ring in remembrance of me it is not from my disrespect to him that I have not bequeathed to him a larger legacy but because he and his children are most amply provided for by the late **Mr William Collins** and I have disposed of my property amongst those to whom I consider it will be most useful

and after the death of the survivor of them the said **George Arrowsmith** and his said four children as to such part of my personal estate as shall be subject to the payment of the said annuity of £200 to them and the survivor of them and also as to the principal sum of £4,000 stock the interest whereof is limited in trust for the said **Sarah Anne Cotton** for her life And also as to all the rest and residue of my stock in the funds and other my personal estate and effects whatsoever not otherwise bequeathed or disposed of upon trust to assign transfer and pay the whole thereof unto my said niece **Sarah Anne Cotton** for her sole and separate use and not to be subject to the debts control or interference of her present or any future husband and I will and direct that her separate receipt or receipts for the same whether she be covert or sole shall be an effectual discharge or effectual discharges for the money therein mentioned and acknowledged to be received And I hereby will and declare that the receipt or receipts of my said trustees or trustee for the time being for any money payable to them or him under this my Will for the purchase of my said freehold and leasehold estates or any of them or for any other matter or thing shall effectually discharge the person or persons paying the same from being obliged to see to the application thereof or from being answerable or accountable for the misapplication or nonapplication thereof

And I will and direct that if the trustees appointed in this my Will or to be appointed as hereinafter is mentioned or either of them their or either of their heirs executors administrators or assigns shall happen to die or be desirous of being discharged from or refuse or decline or be incapable to act in the trusts hereby in them respectively reposed as aforesaid before the said trusts shall be fully executed then and in such case and as often as the same shall happen it shall be lawful for the surviving or continuing trustee or trustees or the executors or administrators of the last surviving or continuing trustee by any deed or deeds instrument or instruments in writing to be by him or them sealed and delivered in the presence of and attested by two or more credible witnesses from time to time to nominate substitute or appoint any other person or persons to be a trustee or trustees in the stead or place of the trustee or trustees so dying or desiring to be discharged or refusing or declining or becoming incapable to act as aforesaid

and when and so often as any new trustee shall be nominated and appointed as aforesaid all the said trust estates monies and premises or such of them as shall then remain subject to the trusts aforesaid shall be thereupon with all convenient speed conveyed assigned and transferred in such sort and manner and so that the same shall and may be legally and effectually rested in the person or persons so to be appointed as aforesaid either solely or jointly with the surviving or continuing trustee or trustees as occasion shall require upon and for the trusts hereinbefore declared of and concerning the said trust estates monies and premises or such of them as shall then be subsisting undetermined and capable of taking effect and every person so to be appointed as aforesaid shall have all the powers and authorities of the trustee in whose room he shall be substituted

and I hereby further declare that the said several trustees hereby appointed and to be appointed as aforesaid and each and every of them and their and each and every of their heirs executors administrators and assigns shall be charged and chargeable respectively for such monies only as they respectively shall actually receive by virtue of the trusts hereby in them reposed notwithstanding their or any of their giving or signing or joining in giving or signing any receipt or receipts for the sake of conformity and any one or more of them shall not be answerable or accountable for the other or others of them or for involuntary losses and also that it shall be lawful for them with and out of the

monies which shall come to their respective hands by virtue of the trusts aforesaid to retain to and reimburse themselves respectively and also to allow their respective co trustees all costs charges damages and expenses which they or any of them shall or may suffer sustain expound disburse or be put to in or about the execution of the aforesaid trusts or in any wise relating thereto And I hereby revoke all former Wills and testamentary bequests by me at any time heretofore made and do declare this to be my only last Will and Testament

And lastly I hereby appoint the said **Anthony Mervin Reeve Storey Peter Templeman** and **Thomas Andrews** to be executors of this my last Will and Testament In witness whereof I the said **Henry Rigby** the testator to the first four sheets of this my said last Will and Testament have subscribed my hand and to this fifth and last sheet thereof have subscribed and set my hand and seal the day and year first before written **Henry Rigby** (ls) signed sealed published and declared by the said **Henry Rigby** the testator as and for his last Will and Testament in the presence of us who at his request in his presence and in the presence of each other have hereunto subscribed our names as witnesses - **Peter Harrison** curate of Fisherton Anger - **Chas. Hill** junior clerk to **Mr Winch** att. at law Salisbury - **Elizabeth Eyres** servant to **Mr Winch** att. at law Salisbury

I hereby give and bequeath to my servant **Robert Dixon** if he should be living in my service at my death in addition to the several articles I have left him under a former codicil the sum of £30 - **H. Rigby** (ls) witness my hand and seal this 8th day of April 1819 witnesses - **Joseph Bell** - **Mary Bell** - **Philip Clouter**

I **Henry Rigby** of the city of New Sarum in the county of Wilts clerk do declare this to be a codicil to my last Will and Testament whereas by my said Will I have appointed **Anthony Mervin Reeve Storey** of the Temple London esquire to be one of the trustees and executors of my said Will I hereby revoke the said appointment of the said **Anthony Mervin Reeve Storey** and declare the same to be null and void and I confirm my said Will in all other respects In witness whereof I have hereunto set my hand and seal the 11th day of August 1818 - **Henry Rigby** (ls) signed sealed published and declared by the said **Henry Rigby** as and for a codicil to his last Will and Testament in the presence of us who in his presence and at his request have signed our names as witnesses - **Thos. Wilde Dyke** - **M.A. Skinner** - **Sarah Skinner**

I **Henry Rigby** of the city of New Sarum in the county of Wilts clerk do make and declare this to be a codicil to my last Will and testament which bears date the 3rd day of November 1817 that is to say I hereby nominate constitute and appoint **Thomas Cotton** of Enfield in the county of Middlesex esquire his heirs executors and administrators to be a trustee and trustees of my real and personal estates devised by my said Will for and upon the trusts intents and purposes expressed in my said Will And I also appoint the said **Thomas Cotton** an executor of my said Will and I confirm my said Will in all other respects In witness whereof I have hereunto set my hand and seal the 21st day of September 1818 **Henry Rigby** (ls) signed sealed published and declared by the said **Henry Rigby** as a codicil to his last Will and Testament in the presence of us who in his presence at his request and in the presence of each other have hereto set our names as witnesses - **Thos. Winch** att. at law Salisbury - **Edw. White** - **Chas. Hill** junior clerks to **Mr Winch**

If my servant **Robert Dixon** should be living with me at the time of my decease I give and bequeath to him the following articles all my wearing apparel my large silver shoe buckles silver x buckles a smaller pair of silver shoe buckles my silver stock buckle all my shaving apparatus my inkstand my bureau now standing in the lumber room all my brewing utensils except fixtures all my linen such as shirts stocks stockings except two India handkerchiefs I give and bequeath to my servant **Sarah Small** if she should be living with me at the time of my death the sum of £5 and mourning I give and bequeath to **Mr Thomas Prower** the sum of £20 I give my worthy and much esteemed friend **Mr Winch** solicitor the sum of £20 I give my intimate friend **Dr Skinner** a ring and a ring likewise to the **Rev Mr Harrison** of Fisherton Anger I request **Mr Peter Templeman** one of my executors to accept of a ring not for its value but as a small token of my friendship and regard for him I give and bequeath to **Mr Winch** senior the sum of £10 I give my nephew **Mr Collins Rigby** my cornelian seal or x crest set in gold I give my nephew **George Arrowsmith** my folio Bible and Testament witness my hand this 7th day of October 1818 - **Henry Rigby** (ls) signed sealed and delivered in presence of us - **Anna Maria Bowles** - **Elizabeth Bowles** - **Elizabeth Hayward**

I hereby and bequeath to **Sarah Small** widow if she should be living with me at the time of my death (cancelling all her former codicils I have hitherto made in her favour) the sum of £30 witness my hand and seal this 15th day of April 1819 - **H. Rigby** (ls) witnesses **Joseph Bell** - **James Bennett** - **Philip Clouter**

Proved at London with 5 codicils 24th May 1819 before the worshipful **John Dauberry** Dr of Laws and Surrogate by the oath of **Thomas Andrews** one of the executors named in the Will and **Thomas Cotton** esquire the executor substituted in the second codicil to whom Admon was granted being first sworn duly to administer power reserved to **Peter Templeman** esquire the other executor named in the Will.
