Constantia Chadwick Michell

Will dated 27th December 1849

Proved 14th January 1850

This is the last Will and Testament of me **Constantia Chadwick Michell** of Lymington in the county of Southampton spinster commanding my soul to the mercy of Almighty God through the merits of my saviour Jesus Christ I will and dispose of all my worldly goods in manner following (that is to say) first I will and direct that all my just debts and funeral and testamentary expenses be fully paid

I give unto my dear brother in law the **Reverend Henry William Robinson Luttmann Johnson** of Binderton in the county of Sussex clerk the sum of £100 sterling also unto my dear brother **William Michell** the like sum of £100 sterling and I direct my executrix and executor hereinafter named to pay the legacy duty payable upon the said legacies of £100 and £100 out of my personal estate

I also give and bequeath unto **Mary Fennell**? now in the service of **Mrs Young** Government House St Helena the sum of £10 sterling also unto **Emily Towgood** of St Neots in the county of Huntingdon spinster the sum of £19. 19s. sterling also unto my mother's goddaughter **Maria Catherine Anderson** the daughter of my cousin the **Reverend Richard Anderson** of Burneston in the county of York clerk the like sum of £19. 19s. sterling

also unto the **Reverend James Hutchins** of Telescombe in the county of Sussex clerk the like sum of £19. 19s. sterling also to my godson **James Arthur Luttmann Johnson** the like sum of £19. 19s. sterling also unto my goddaughter **Sarah Jane King Sampson** the like sum of £19. 19s. sterling and also unto my servant **Mary Knapper** the sum of £5 sterling together with suitable mourning

And as to all the rest residue and remainder of my personal estate and effects whatsoever and wheresoever and all my real estate whatsoever and wheresoever I give devise and bequeath the same and every part thereof unto my dear sister **Maria Elizabeth Michell** her heirs executors administrators and assigns absolutely and for ever

And I do hereby nominate constitute and appointment my said dear sister **Maria Elizabeth Michell** and my said brother in law **Henry William Robinson Luttmann Johnson** executrix and executor of this my last Will and Testament and I do hereby revoke all former Wills and codicils by me heretofore made

And I do hereby declare this to be my last Will and Testament in witness whereof I have hereunto set my hand this 27th day of December 1849 – **Con. C. Michell** signed and declared by the said **Constantia Chadwick Michell** as and for her last Will and Testament in the presence of us who in her presence and at her request and in the presence of each other have subscribed our names as witnesses thereto –

Proved at London 14th January 1850 before the worshipful **James Parker Deane** doctor of laws and surrogate by the oath of the **Reverend Henry William Robinson Luttmann Johnson** clerk one of the executors to whom admon was granted having been first sworn duly to administer power reserved of making the like grant to **Maria Elizabeth Michell** spinster the sister the other executor when she shall apply for the same
