I give and bequeath unto Mary Elizabeth Goodenge calling herself Mary Castle now residing with me at no 40 New Road in the parish of Saint Mary le Bone in the county of Middlesex one annuity or clear yearly sum of £100 during the term of her natural life payable quarterly I give to William Tomlyn of Salisbury banker the sum of £500 also the like sum of £500 to Elias Hibbs of Monument Yard London wine merchant I give to my uncle Mr John Cooper of Salisbury one annuity or clear yearly sum of £100 during the term of his natural life payable half yearly I give £250 apiece to Harriet Dennett and Frances Eliza Dennett the daughters of Jonathan Dennett of Leicester Place gentleman I give to the Reverend Edward Cooper of Yetminster near Sherborne in Dorsetshire the sum of £500 I give £250 and my gold watch to my friend Mr Robert Dennett I give the sum of £100 to Miss Sarah Greaves and the like sum of £100 to each of her brothers William Greaves and Robert Greaves I give to Henry Stevens of Salisbury gentleman the sum of £100 I give to William Havers of Salisbury the sum of £100 and the like sum of £100 to John Dowding my clerk I discharge John Luxford my overseer from the payment of all debts claims and demands which I have against him I also release and discharge Mr Thomas Williams of Vere Street from the payment of all debts claims and demands whatsoever due to me alone or jointly with any of my present or late partners I also give and bequeath to my cousin Frances Henrietta Elderton now or late of Salisbury the sum of £500

and lastly I do hereby nominate constitute and appoint the said Sir George Staunton Townley Ward of Soho Square in the county of Middlesex esquire the said Peter Bellinger Brodie and Barford Colton executors of this my Will hereby revoking and making void all former and other Wills by me at any time heretofore made and do declare this to be my last Will and Testament as witness my hand and seal this 19th day of August in the year of our Lord 1796 - Benjamin Chas. I Benjamin Charles Collins of Salisbury in the county of Wilts esq do publish and declare this present writing as and for a codicil to my last Will and Testament dated the 19th day of August now last past whereas in and by my said Will after payment of my just debts funeral expenses and legacies and sums of money therein mentioned I have given devised and bequeathed all the rest residue and remainder of my estate and effects of what nature or kind soever and wheresoever both real and personal unto my dear mother Mary Collins my bother in (sic) Sir George Staunton my brother in law the Reverend Peter Bellinger Brodie my brother in law the Reverend Barford Colton and my brother William Collins to have and to hold the same unto them their heirs executors administrators and assigns equally between and amongst themselves and share alike as tenants in common and not as joint tenants and I have also in and by my said Will appointed the said Peter Bellinger Brodie one of my executors and I have likewise in and by my said Will given and bequeathed unto William Tomlyn of Salisbury banker the sum £500 and to the Reverend Edward Cooper of Yetminster near Sherborne in Dorsetshire the like sum of £500 and to my cousin Frances Henrietta Elderton then or late of Salisbury the sum of £500

Now I do hereby revoke and make void so much of my said Will as relates to or concerns the several bequests therein contained to the said Peter Bellinger Brodie William Tomlyn, Edward Cooper, Frances Henrietta Elderton and also the appointment of the said Peter Bellinger Brodie as such executor as aforesaid and I do hereby give and bequeath unto Townley Ward one of the executors named in my said Will the sum of £100 and the like sum of £100 to Mrs Ward wife of the said Townley Ward and I the said Benjamin Charles Collins do hereby nominate and appoint Jonathan Dennett in my said Will named another executor in my said Will and I do give and bequeath unto the said Jonathan Dennett the sum of £100 and to Mrs Dennett wife of the said Jonathan Dennett the sum of £100

Memorandum Friday April 21st 1797

It was on the 7th day of July 1792 that I delivered by letter the enclosed draft value £769 to my most able and faithful solicitor **Townley Ward** esq as and for his own sole and entire use in grateful yet humble token of my sense of the many and important services rendered to me and to my family during a long and most arduous executorship the same being in part a small portion only of my share of very large sums wrested by his able head from the hands of needy and artful villains namely **Maurice Lloyd**, **Viscount Newhaven** and **Gregory Bateman** as also from rogues of lesser note all which services were done and rendered without law and litigation the more meritorius this and to the estate of **Benjamin Collins** my father deceased immensely advantageous for the experience of time has shewn that had a chancery suit or even the usual delays of a nisi prius court taken place a very great portion of the large sums so recovered must have been lost

All these three swindlers being long since dead and the two last named died insolvent it was on this day the 21st of April 1797 that my worthy and honorable friend **Mr Ward** returned to my hands this draft and as he was peremptory that I should take it I did so but I now give it herewith unto the hands of my esteemed friend and solicitor **Mr Robert Dennett** by him to be placed herewith in my last Will and Testament in his keeping and in case of my death by him to be delivered unto the hands of his brother one of my executors for the uses and purposes of **Mr Ward** or as he only shall direct and all this I declare to be a codicil to my aforesaid Will signed with my name and sealed with my seal this 21st day of April 1797 - **Ben. Chas. Collins**

This is a codicil to my Will in the hands of Robert Dennett esq of Covent Garden London I owe not one penny to my fathers estate in any way I owe not one penny to all or any of my late partners in the banking business I give to Robert Dennett aforesaid to this brother Jonathan and to his partner William Greaves esq £3,500 In trust £500 for Frances Eliza Dennett and the residue for Maria Castle (so called) at Mrs Butts Ladies School Great Marlbro Street Carnaby Market the said Maria to be a Ward of Chancery - B.C. Collins

2nd May 1808

Appeared personally Gerard Selby of Lincolns Inn Fields in the county of Middlesex gentleman and made oath that on the 6th day of February last he went down to the city of Salisbury for the purpose of being present at the examination of the papers of Benjamin Charles Collins late of Salisbury aforesaid esq deceased who died as this deponent has been informed and believes on the 24th day of the oath of January last past and of selecting those of a testamentary nature that on this deponents arriving at Salisbury a search was made by him and William Collins esq Samuel Emly esq John Luxford and John Dowding gentlemen of Salisbury aforesaid and the said deceased's papers were carefully examined and on examining a memorandum book purporting to be the daily journal for the year 1801 containing different memorandums of the said deceased was found by the said Samuel Emly locked up in the said deceaseds bureau situate in the dining parlour in the presence of this deponent and of the said other persons that the said book was immediately examined and on reading the same a codicil was found therein written in a page of the said book described Memorandums and Resolutions as at the end of the year 1801 the said codicil beginning thus 1801 Dec...(verifying the authenticity of the codicils).

This Will was proved at London with four codicils the 6th day of May in the year of our Lord 1808 before the worshipful George Ogilvie Doctor of Laws Surrogate of the Right Honourable Sir William
