

George Arrowsmith Will dated 13th August 1849 Proved 3rd May 1851

This is the last Will and Testament of me **George Arrowsmith** late of Percy Street in the parish of Northfleet but now of Northfleet in the county of Kent I appoint my son **George Arrowsmith** sole executor of this my Will

I give and bequeath unto my son **Henry George Arrowsmith** the sum of £500 I give and bequeath unto my son **Benjamin Yarrow Arrowsmith** the sum of £100 I give and bequeath unto my son **Thomas Charles Arrowsmith** the sum of £100 I give and devise all my estate and interest in certain messuages or tenements lands hereditaments and premises situate at Upton upon Severn in the county of Worcester and also all my estate called Wintershaw situate lying and being at Westgate, Dorking in the county of Surrey unto my said son **George Arrowsmith** his heirs and assigns for ever

I give and bequeath all my leasehold estate situate in and being in Bouverie Street in the city of London unto my said son **Benjamin Yarrow Arrowsmith** his executors administrators and assigns for his own use and benefit I give and bequeath all my leasehold estate situate and being in Theberton Street, Islington in the county of Middlesex unto my said son **Thomas Charles Arrowsmith** his executors administrators and assigns for his own use and benefit I give and bequeath my leasehold messuage or tenement situate and being number two Canterbury Place, Walworth in the county of Surrey unto my son **Henry George Arrowsmith** his executors administrators and assigns for his own use and benefit I give and bequeath unto **Jane Holloway** widow £150 and the furniture and effects in and about the house in her occupation at Northfleet (my plate excepted)

And as to my leasehold estate situate and being at Highbury Park in the county of Middlesex I give and bequeath the same unto **Peter Graham** of Oxford Street his executors administrators and assigns upon trust that he and they do and shall receive the rents issues and profits thereof until my grandson **George Graham** shall attain his age of 21 years In trust to pay and apply the same from time to time for the benefit of my said grandson **George Graham** in such manner as the said **Peter Graham** his executors or administrators shall deem most beneficial to my said grandson and when and so soon as my said grandson shall attain his age of 21 years I give and bequeath the same estate at Highbury Park aforesaid unto my said grandson **George Graham** his executors administrators and assigns to and for his and their own use and benefit absolutely I give and bequeath all the rest residue and remainder of my personal estate and effects whatsoever and wheresoever unto my said son **George Arrowsmith** for his own use and benefit

And I hereby revoke all former Wills by me at any time heretofore made and declare this only to be my last Will and Testament In witness whereof I have here under set my hand to this my Will this 13 day of August 1849 - **Geo Arrowsmith** - signed by the said testator as his last Will and Testament in the presence of us present together at the same time who at his request in his presence and in the presence of each other have subscribed our names as witnesses the word Henry in the first line of the second side having been first introduced - Francis Southgate solicitor Gravesend - Francis Thos Southgate solicitor Gravesend.

Proved at London 3 May 1851 before the worshipful James Parker Deane Doctors of Laws and Surrogate by the oath of **George Arrowsmith** the son the sole executor to whom Admon was granted having been first sworn duly to administer.
