Elizabeth Ahmuty the daughter of Arthur Ahmuty 1730-1793 and Ursula Da Cruz married in 1803 Philip Tuite Dalton 1781-1853 of co Meath and they had a daughter Charlotte Tuite Dalton who married Felix Droina? Philip Tuite Dalton was the son of Edward Dalton and Frances Tuite and on the 12 May 1808 witnessed the marriage of his brother in law Richard Ahmuty 1774-1816 to Sophia Barker.

Philip Tuite Dalton 1781-1853

Philip Tuite Dalton was born in co Meath Ireland the son of Edward Dalton and Frances Tuite. He married Elizabeth Ahmuty the daughter of Arthur Ahmuty 1730-1793 and Ursula Da Cruz and they had a daughter Charlotte Tuite Dalton who married Felix Droina? On the 12 May 1808 Philip Tuite Dalton was a witness to the marriage of his brother in law Richard Ahmuty 1774-1816 to Sophia Barker.

Philip Tuite Dalton entered Trinity College, Dublin at 14 years of age as a Fellow Commoner on the 10 November 1795 and graduated the summer of 1799 with a Bachelor of Arts degree; prior to entering Trinity College his schoolmaster was Mr Brickell.

Philip Tuite Dalton became a Lieutenant of Lancers in the British Army and his Regimental Agents were Cox & Co of Craig's Court, London. In his Will dated 10 August 1849 he appointed John Weston and Henry Thomas Lambert the executors and named his wife Elizabeth Tuite Dalton of Algiers, daughter Charlotte Tuite Dalton of Rouen, nephews Gustavus and Edward Tuite Dalton, George Howard Minchin, the Marquess of Headfort and the Earl of Bective.

His brother Edward Tuite Dalton married Olivia Stevenson the daughter of Sir John A Stevenson the Director of Music for Trinity College Dublin and they had three children Gustavus Tuite Dalton 1811-1878, Edward Tuite Dalton 1815-1880 and Adelaide Tuite Dalton 1819-1895 who married John Young the 1st Baron Lisgar.

Olivia Stevenson married secondly in 1822 Thomas Taylour the 2nd Marquess of Headfort grandson of Caroline Cavendish 1740-1801 by her first marriage to George Quin 1729-1791; Caroline Cavendish married secondly Thomas Ahmuty 1731-1801 on the 18 August 1792 at Bath Somerset.

The death is announced of Major-General Edward Tuite Dalton C.S.I. who entered the army in 1835 and took
part in expeditions against the frontier tribes of Assam in 1839-40 and 1842. When two French missionaries,
M.M Kirk and Bourry had been murdered on the Tibetan frontier by a Mishmi chief, General Dalton received
much praise for his skill in organising the expedition which captured the murderer. Our associate died at
Cannes on December 30th in the sixty-fifth year of his age

Philip Tuite Dalton 1781-1853

Summary of Will dated 10 August 1849 with two codicils proved 14 November 1853
Philip Tulte Dalton of no. 4 York Street in the Parish of St James, London a Lieutenant of Lancers desired his gold and ivory snuff box be offered for the sum of £20 firstly to the Marquess of Headfort and secondly to the Earl of Bective and if neither were willing to take it at that price then to be sold to best advantage. His gold watch was left to daughter Charlotte residing in Paris 27029 Rue Croix des Petits Champs and his French silk tissue dressing gown left to nephew Gustavus Tuite Dalton of county Cavan Ireland. He left to George Howard Minchin MD of Dublin all wearing apparel books glass and all such other effects, his wife Matilda Howard Minchin (nee Freeman) a miniature picture of a Lady and in trust for their daughter Matilda Charlotte Minchin a small brown Russian leather portfolio and damask napkins with any other table linen.

The executors Henry Thomas Lambert and John Weston of 57 Gloucester Road, Hyde Park Gardens and of 23 Suffolk Street, Strand were to take at their own valuation or otherwise dispose of such wines as may be found in any cellar he may own or elsewhere and to pay half the amount of such valuation or sale to Thomas Albrecht of Paris. Any money and balance of half pay was in the hands of his agents Messrs Cox & Co of Craig's Court and such sum together with the proceeds from his apartment, sale of the snuff box and wine should defray funeral expenses, pay all debts and leave a balance payable to his daughter Charlotte for own sole use and benefit of her daughter Marie. Thomas Albrecht was to remit to the executors the outstanding balance shown in the monthly report of receipts and disbursements the copies in a book kept for that purpose and said balance paid to his daughter. The executors were to collect and receive the accounts for wines as owing to him personally shown in the pay book in their possession and after deduction of the first cost of the wines payable to the house of Messrs F Grisler & Co were to pay the balance to his daughter Charlotte.

I declare this to be my last Will and Testament in witness whereof I the said Philip Tulte Dalton have to this my last Will and Testament set my hand and seal this 10th day of August 1849 signed by the testator Philip Tuite Dalton in the presence of us present at the same time who have hereunto subscribed our names as witnesses in the presence of the said testator and of each other Thomas Staples. Elizabeth Staples.

Codicil dated 15 August 1851

Having received a bequest from his late deceased friend Oliver Lacham? and at the Bank having £400 3% annuities, the executors were to remit to Thomas Albrecht of Paris the sum of £40 requesting it be forwarded to Madame Elizabeth Tuite Dalton now residing at 27 Rue Bolissaire, Algiers. The executors were left in trust the £400 3% principal and interest with all other moneys after payment of debts and funeral expenses for the sole use and benefit of his daughter Madame Charlotte and granddaughter Mademoiselle Marie and from the time of his death his daughter was to receive 100 francs per quarter. He stated the portfolio and miniature had already been disposed of and that the table glass was to remain with the proprietor of his apartment. Doctor Minchin was left wearing apparel with suitable items to be given to the male servant.

I declare this to be a codicil to my Will made the 10th of August 1849 in witness of which I do hereby set my hand and seal this 15th day of August 1851 signed by the testator Philip Tulte Dalton in presence of us present at the same time who have hereunto subscribed our names as witnesses in the presence of said testator and of each other, x Jermyn Street. Mrs E Staples 4 York Street.

Codicil 5 September 1853

A second codicil to the last Will and Testament of Philip Tuite Dalton of 4 York Street, St James London but now stopping at Rinostown Ireland. He stated he owed his nephew Gustavus Tuite Dalton the gold and ivory fronted snuff box and gave his watch and seal to his nephew Captain Edward Tuite Dalton principal assistant commissioner East India Company service. The damask napkins were left in trust to Doctor Minchin of Peters Place, Dublin for his daughter Charlotte Minchin in fulfillment of an old promise. The executors as previously appointed in his Will (which was now at his London residence) were directed to give the table glass or china to the landlord or landlady of his London apartment and to distribute five pounds amongst the servants in service with suitable items of wearing apparel given to the manservant or boy.

The executors were left in trust the 3% annuities or other public stocks, arrears of half pay in the hands of Messrs Cox & Co and the balance owed by Thomas Albrecht of Paris shown in a book containing copies of the monthly accounts together with all money on his person, in apartments and from the sale of personal effects and wine. The executors with all convenient speed were to pay his wife Madame Elizabeth Tuite Dalton now residing at 27 Rue Bolissaire, Algiers the sum of 2000 francs French money and upon further trust to pay with like speed the sum of 500 francs to his daughter Charlotte now residing at 83 Rue de Carrefour Cotterville? near Rouen France

The executors were to invest in trust the residue in Parliamentary stocks, in Public funds of Great Britain or other securities and with the assent of his daughter in writing were to call in and vary such investments or by the purchase of an annuity. His daughter was to receive the interest dividends or annuity for sole and separate use not subject to the debts control or interference of her present or any future husband and after her decease and if no annuity had been purchased all funds invested in trust for person or persons as his daughter shall nominate by her last Will and Testament or appoint in writing and in default of such direction all funds to be invested in trust for her daughter Marie executors admin assigns.

in witness whereof I have to this second codicil to my last Will and Testament signed my name this 5th day of September 1853 Philip Tulte Dalton signed published and declared by the above named testator as and for a codicil to his last Will and Testament in the presence of us who at his request in his presence and in the presence of each other have subscribed our names as witnesses x x Edwin Battersby, South Frederick Street.

Proved at London with two codicils the 14th November 1853 before the Worshipful William Calverley Curteis Doctor of Laws and Surrogate by the oath of John Weston and Henry Thomas Lambert esquires the executors to whom admon was granted having been first sworn duly to administer.

Philip Tuite Dalton entered Trinity College (matriculated) as a Fellow Commoner on the 10th November 1795 aged 14. He was the son of Edward Tuite Dalton whose profession was listed as a Gentleman and was born in County Meath. He had a Bachelor of Arts degree conferred on him in the summer of 1799 and Mr Brickell was his schoolmaster before entering the College.

S.C. Socius Comitatus - Fellow Commoner.

They paid double fees and enjoyed several privileges including that of finishing the College course in three instead of four years.
