The House of Gregory

Sir John Keane: I move:—

That the Seanad invites an explanation from the Minister for the Co-ordination of Defensive Measures in regard to the attitude adopted towards the **copyright** of the book entitled **The House of Gregory**.

I find among certain Senators and members of the public who have seen this notice of motion considerable ignorance of what it involves. That perhaps is natural, but I should like to say at the outset that it involves matters of very grave Constitutional import and I do hope that I shall have the attention and the sympathy of the House in what I have to say. In that connection, I make an appeal that members of the House will approach this matter more in the spirit of jurymen than from any standpoint of Party allegiance. I think you [711] will find that those remarks are justified when you hear the case as it develops.

"The family of Gregory originated in England. Members came over and settled in Ireland where they acquired estates. One of them took a considerable part in the defence of Derry and afterwards settled in Kerry, while one of his sons preferred Galway.

The latter was father of **Robert Gregory who became chairman of the East India Company** who it is said left **Galway as a stowaway but he had introductions to prominent persons in India and through these obtained a writership and clerkship in the company. He managed to amass a fortune and when little over 40 he returned to England and thenceforward lived a life of affluence.**

A descendant in the last century who served as Governor of Ceylon and an English M.P. was the husband of the famous **Augusta Lady Gregory** who having survived her husband for several decades, died only a few years ago. The author of this family memoir was a cousin of Sir William Gregory. He became a student of Trinity College and graduated there in Arts and Law and joined the old R.I.C. as a cadet. He was stationed in North Kerry during part of the 'Troubles' and subsequently in Antrim. While in Kerry he had a day's fishing under the protection of an I.R.A. leader. Unfortunately he landed not a single fish. If he did, he would have it preserved as a fish poached by a police officer without a licence or the permission of the owner, under the auspices of an I.R.A. man. In the North he did not find people so accommodating. He was asked by a fly-tying fanatic to secure feathers of a game-cock killed in November. As a police officer, Mr. Gregory's duty was to put down cock-fighting. But he could not let the angling friend down. He made approaches to the proper quarters through the proper channels but there was nothing doing. The Northern cock-fighters were not as trustful or obliging as the Kerryman. The book contains grim and [736] humorous reminiscences of troubled times in Ireland as well as memoirs of the author's ancestors."

Such a book might have been dull. It might have been a collection of pedigrees and genealogies but fortunately the Gregorys do not lend themselves to dullness and so we have a book which is not merely a pious family record but a book which holds out great promise of entertainment to the people of Ireland who read it. They will read there of cock-fighting and of duelling, of horse races, of fishing and of shooting—things [751] which the Irishman likes. They will read of an **Irishman who left Ireland as a cabin boy or stowaway and who rose to the position of head of the East India Company**

Letter from **Robert Gregory, Cool [Galway, Ireland]**, to [W.H.C. Cavendish-Bentinck], 3rd Duke of Portland;
Writes to inform the duke about the state of County Galway; states that 'a great proportion of the Common People are ready for any mischief'; mentions disturbances which have been spreading; notes that several people have been arrested and two found guilty; notes that there has been no 'open act of violence' in the south west of the county; thinks the poor are being encouraged by a certain type of person, only to be found in Ireland **'that call themselves Gentlemen without a single Qualification to Intitle them to that Distinction'**;
comments that these people manage to keep themselves out of reach of the law. Notes that the alleged cause for the disturbance is 'the High Price of lands let to the poor, oppression in the exaction of the Tythes and the Low wages of labourers'; claims that there is no such cause for complaint in County Galway; explains why this is his belief; has stated to his tenants what will happen to them if they are guilty of disturbing the peace; assures the duke that propertied men of all religious persuasions are attached to the king's government;
congratulates the duke on the marriage of the Marquess of Titchfield;
concludes by noting that only three of the recruits [of the East India Company] sent out on the '**Brilliant**' arrived at **Bombay**; says **Robert Wright** was not among them. 2 ff

Robert Gregory 1774-1810

Biographical note: **Robert Gregory** (1727-1810) was born in Ireland. He made his fortune as a merchant in India. In 1766 he settled in Kent, England and served as a member of the British Parliament (1768-1784). He also served as a director of the East India Company (1769-1782) and as chairman of the Court of Directors in 1782. He married **Maria Auchmuty** and they had three sons, Robert (1754-1814), Richard (1761-1839), and William (1766-1840), and one daughter, Margaret.

Abstract:

The series consists of papers of **Robert Gregory** from 1774-1810. The papers include correspondence; official records such as minutes, reports, and financial papers; and printed material relating to his service as a director at the East India Company. The correspondence (bulk 1778-1783) contains letters from various individuals reporting on the business of the East India Company and its activities in India during the English occupation and particularly during the Maratha Wars. The official records of the East India Company include minutes of the Court of Directors (June- Sept. 1779), financial reports and records from Bengal (1777-1784), a summary of proceedings relative to Rajah Cheyle Sing (1775), an account of sums of money given by the Nabob of Arcot for bringing about the revolution (1776), a brief state of the British affairs in India from January 1 to November 30, 1780, and a holograph copy of a treaty of peace with the Nabob Tippoo Sultaun Bahauder (1784).

Obituary April 1840

The Right Hon **William Gregory** for many years Under Secretary of State in Ireland, has paid the debt of nature. Full of years and of honours, his grey hairs have descended to the grave, and in the joyful expectation of the resurrection of the just, he rests from the labours of a well spent life. We write but an obituary and not a memoir; else could we dilate with pleasure to ourselves, and with profit to our readers also, on the integrity of purpose the clearness of intellect, the knowledge of the world, the capacity in men and things, which distinguished this excellent gentleman as a public functionary, and placed him for efficiency in office far beyond all rivalry. No man knew the country better than he did. His discernment kept him from all deception, his resolution from weakness or inconsistency-his tact and temper from precipitance or blunder. The good rejoiced in his protection-the weak trembled at his vigilance. In the domestic and social circle, we are guilty of no exaggeration in saying that there never lived an individual who enjoyed more largely than he, the respect, the confidence, the love of his friends and associates - nor one whose qualities more richly deserved the sympathies of friendship and the devotion of love. Gentle and affectionate, polite and affable-intelligent and communicative, his manners won an easy way into the esteem of his acquaintance; whilst the sterling worth of his nature, and the unvarying integrity of his life rivetted to him the hearts of all who by congenial disposition, shewed themselves worthy of his regard. Long will such a man be mourned by his country. Deep and lasting will be the tribute of sorrow which his surviving friends will pay to the memory of a departed spirit whose walk in life had been as much distinguished by public services and was graced by private and domestic virtue.

A pension of £445 devolves on the Civil List by the death of Right Hon **William Gregory** of Coole co. Galway, Ex-Under Secretary for Ireland, brother-in-law of the late (2nd) Earl of Clancarty, to whose sister, **Lady Anne Trench** he was married in 1789

Lady Gregory was born Isabella Augusta Persse in 1852 in Roxborough House, near Loughrea, Co. Galway. At twenty-eight she married Sir WH Gregory then a sixty-three year-old widower, former **Governor of Ceylon** and Trustee of the National Gallery and MP for Galway and who had been responsible for measures which compounded the misery suffered in the Great Famine 1846-1851. They settled in London where the Gregorys' salon was frequented by Browning, Tennyson, Millais, Henry James, and others. They summered at Coole Park near Gort co Galway in the barony of Kiltartan which she would later make famous. Her husband died in 1892 and shortly afterwards, her first visit to Inisheer one of the Aran Islands inspired her to learn Irish and the Hiberno-English dialect of Kiltartan. She met W. B. Yeats in 1896 and commenced collecting folklore in Kiltartan region with him. She also established an Irish class at Coole schoolhouse.

In the name of God amen. I **James Daly of Dunsandle in the County of Galway Esq.**, but now resident in **Dominick street** in the city of **Dublin** being in a weak state of health but of sound and disposing mind and memory, thanks be to God for the same, do make my last will and testament in manner and form following, hereby revoking all former wills at any time heretofore by me made and first I bequeath my soul to Heaven, Hoping that whatever advantages reserved for the souls of the deceased, I may through the Mercy of God partake of the benefits of them, as I am not conscious thro the whole course of my life of having acted by any of my fellow creatures in such a manner as should incur the Divine displeasure, but having behaved with regard to others with as much Beneficence as common sense and prudence permitted me, and whereas by the settlement made previous to my marriage with **Catherine Daly otherwise Gore my present much beloved wife** a sum of eight thousand pounds is charged upon certain lands and estate therein mentioned and provided for the portions of my younger children to be paid to and distributed among them at such times and in such shares and proportions, and with such yearly interest for their respective maintenance until such portions should become payable as I should think fit to limit or appoint,

and whereas I have at this time living **seven younger children by the said Catherine**, to wit **two daughters and five younger sons**, now in pursuance and execution of the power so vested in me, it is my will and I do hereby limit and appoint that the sum of two thousand pounds part of the said of eight thousand pounds shall be raised and paid to my **eldest daughter Elizabeth Daly** at her obtaining the age of twenty one years or day of marriage, which soever shall first happen, in part of the portion which I intend her together with interest for the same at the rate of five pounds per centrum from the day of my death till the said sum shall become payable, and I hereby further limit and appoint that the remaining part of the said eight thousand pounds shall be raised and equally divided between my **youngest daughter Ellen Daly** and my younger sons **Ralph, Peter, James, Richard and St. George Daly** share and share alike, and that the said Ellen's proportion thereof shall be paid to her at her age of twenty years or day of marriage which soever shall first happen and that my said younger sons proportions thereof shall be paid to them at their respective ages of twenty one years in part of the portions which I intended for them and my said daughter Ellen, and I do further limit and appoint that my said daughter Ellen and such of my said younger sons as are now under the age of twelve years shall from the day of my death have and be paid yearly for their maintenance interest at the rate of three pounds per centrum for the respective proportions till they shall respectively obtain to the age of twelve and from that time till they shall respectively attain their age of sixteen years interest at the rate of four pounds per centrum, and from thence interest at the rate of five pounds per centrum till their said respective proportions shall become payable aforesaid.

And I do further limit and appoint that such of my said younger sons as have already obtained the age of twelve years, and are now under the age of sixteen years, shall from the day of my death have and be paid yearly for their maintenance interest at the rate of four pounds per centrum for their respective proportions till they shall respectively obtain the age of sixteen years and from thence interest at the rate of five pounds per centrum till their said respective portions shall become payable as aforesaid - and I do further limit and appoint that such of my younger sons as have already obtained the age of sixteen years shall from the day of my death have and be paid for their maintenance interest at the rate of five pounds per centrum for their respective proportions until the same shall become payable as aforesaid, but if any of my said younger children should happen to die before their respective shares of the said sum of eight thousand pounds shall be become payable it is my will and I do hereby limit and appoint that the share or shares proportion or proportions of the younger child or younger children so happening to die shall go and be equally divided among the survivors or survivor of them, and shall be paid at the same time with their original proportions and in such manner and with such rates of interest, according to the respective ages of such survivor or survivors as herein before appointed to be paid for their original proportions, and whereas by the said settlement a power is also reserved to me to (XXXXXX) and incumber several lands and estates therein for (XXXXX) purpose mentioned with any sum not exceeding ten thousand pounds to be applied and disposed of in such manner (XXXXX) such uses as I shall think fit. Now it is my will (XXXX) in pursuance and execution of the said power (XXXX) the power in me vested accordingly charge and (XXX) the said land and estates with the said sum of (XXXX) thousand pounds sterling and it is my will, and I do hereby (XXX) limit and appoint that the same shall be raised levied and applied as hereinafter mentioned that is to say, I (XXXX) and appoint that the sum of three thousand pounds part of the said sum of ten thousand pounds shall be raised and paid to my said eldest daughter Elizabeth, and the sum of two thousand pounds other part thereof shall be raised and paid to my daughter Ellen, and that the remaining five thousand shall be raised and paid in equal shares to my said younger sons in order to complete the portions and provisions which I intend for my said younger children and

I do hereby direct and appoint that the said respective sums shall be paid to them respectively at such time, and in such manner as their respective shares of the said sum of eight thousand pounds are herein before appointed to be paid and that in the meantime – till the said sum shall become payable that my daughter Elizabeth shall from the day of my death have and be paid yearly interest at the rate of five ponds per centrum for her said proportion thereof, and that my said daughter Ellen, and my said younger sons shall have and be paid yearly from the day of my death interest at the several rates herein before mentioned, according to their respective ages in the same manner as is herein before appointed (XXXX) respect to their shares of the said sum of eight thousand pounds, and in case of the death of any of my said younger children before their said proportions of the said sum of ten thousand pounds shall become payable, it is my will and I do hereby appoint that the share or shares of the child or children so dying shall go to and among the survivor or survivors in such manner and be paid at such times and with such interest and in such manner as is herein before appointed to be done with respect to their shares of said eight thousand pounds upon the like contingencies happening them, I devise and bequeath to my said dearly beloved wife all my plate china household goods and furniture now remaining in Dublin or at **my house at Dunsandle** for her own use and I also devise and bequeath unto her the sum of one thousand five hundred pounds to be paid to her as soon as conveniently may be after my decease of the readiest part of my personal estate in order to provide for her maintenance and support till the highest (XXXX) of her (XXXX) shall become payable and the better to enable her to provide herself with a convenient house for her habitation either in Dublin or where ever else she shall choose to reside after my death.

And I do hereby devise and bequeath all the rest and residue of my personal estate and effects of what kind and nature soever to **Denis Daly my eldest son** subject to the payment of all my just debts, and I do hereby **appoint my said wife and my said son Denis executors** of this my will, and I do hereby also appoint said **dear wife guardian to such of my children** now under age till they shall respectively attain the age of twenty one years, and in case that my wife should happen to die before me or during the minority of any of my said children, I do in that (XXXX) appoint that my said son Denis shall be their guardian in the place of my said wife. I do hereby recommend it to my said son Denis when and as soon as my said younger sons respectively come to age to make such addition to the provisions hereby made for them not exceeding one thousand pounds apiece as he shall think reasonable to make for them or such of them as shall by their conduct and behaviour merit his regard and attention – IN WITNESS whereof I have hereunto put my hand and seal this ----- day of ----- **one thousand seven hundred and sixty nine.**

Letter dated 27 Oct 1950 from Bowes Daly of Dunsandle Estate, PO Iringa, Tanganyika

I trust the following facts I have copied from my family tree may be what you want: **James Daly of Carrownekelly afterwards built & lived in Dunsandle**. He married firstly Bridget daughter of 2nd Lord Anthony, who died without issue. He married secondly, Catherine, daughter of Sir Ralph Gore who afterwards became the Earl of Rosse. (Sir Ralph Gore, the father, was Chancellor of the Exchequer & Speaker of the House of Commons). By Catherine he had 6 sons & 2 daughters, Denis, Ralph, Peter, James, Richard, & St George, Elizabeth & Ellen,

Denis was Speaker of the Irish House of Commons - Grattan's Parliament. He married **Lady Henrietta Maxwell**, daughter of Earl of Farnham. He had 2 sons and 6 daughters. The eldest son James became the 1st Lord Dunsandle & Clarconnel & he had 5 sons & 2 daughters. The title of Dunsandle died out in 1907 on the death of the 3rd Baron & my father came into Dunsandle demesne & half the whole property then about 30,000 acres jointly with his elder brother who had turned R.C. My grandfather & my family all being Protestants. The only reference I can find to the Coughlan family is that Hyacinth Daly (who died 1782) son of a Denis Daly, a nephew of the Carrownekelly one, married the daughter and heiress of the MacCoughlan & had one son & one daughter, the Rt Honorable Denis Bowes who married Charlotte Pousonby & Mary who married Sir Skeffington Smith.

There has been a book published about 15 yrs ago by an American Professor called the History of the O'Dalys, but I have not got it out here. If you know of any affluent Dalys, (if there is such a person in these days) I have a very fine portrait of the Rt Hon Denis Daly speaker in Grattan's parliament & husband of Lady H. Maxwell, by Sir Joshua Reynolds. I want £10,000 for it. I am afraid I am also having to put up for sale my old home at Dunsandle it was built 1744. A sad wrench. Yrs sincerely Bowes Daly

James and Richard as well as daughters Elizabeth and Ellen "attended **Whyte's Classical Academy**, Dublin a private school begun in 1755 and taught by nine clergymen, with Samuel Whyte as Principal"

Whyte's Academy Grafton Street Dublin

was located at no 79 and a plaque bears witness to the fact that a great diversity of famous Irishmen were educated there. It was a unique institution which could produce both Robert Emmett, the great Irish patriot and nationalist who was executed by the British for his part in the failed rebellion of 1803 - and also Arthur Wellesley, a pillar of the British establishment (later to become the Duke Of Wellington). The widely divergent outlook of both men can be gleaned from their most quoted remarks. - in the case of Robert Emmet the arch-patriot, who in his famous speech from the dock said: 'Let not my Epitaph be written until Ireland is Free' compared with the retort of the Duke Of Wellington when it was put to the this seemingly arch-typical English aristocrat that he was in fact born in Dublin - 'if I was born in a stable, would that make me a horse?'

Robert Emmet, From Ireland

... Robert was educated in **Samuel Whyte's academy in Grafton Street** located where **Bewleys Cafe** now stands

Grafton Street

A visit to the street is not complete without a visit to **Bewley's Cafe** a refuge for the foot weary where delicious coffee, tea and cake are served in surroundings of wood paneling and stained glass. The street named in 1812 for the 2nd Duke of Grafton (illegitimate son of Charles 2nd) who acted as Lord Lieutenant of Ireland between the years 1715 and 1723

Colonel Mordaunt's Cock Match 5 April 1784

by Johan Zoffany 1733-1810 Oil on canvas (Oc) 1135 x 1498 mm

The painting depicts a cock match between Asaf-ud-daula, Nawab Wazir of Oudh standing in the centre, and **Colonel John Mordaunt** standing on the left in white, a keen cock-fighter who had brought out from England game-cocks which he was confident would defeat native-bred birds. The outcome of the match is unknown. Cock-fighting was widely regarded as a vicious, ungentlemanly sport.

Captain Robert Smith wrote in the 1830s: 'This barbarous amusement is a particular favourite with the people of Lucknow and is as great a source of demoralisation here, as it is in every country where the custom prevails' (quoted in M. Archer, *India and British Portraiture 1770-1825*, London 1979 p.148)

The picture was commissioned in **1784 by Warren Hastings, the 1st Governor-General of Bengal** shortly before his return to England in 1785. He may have admired a simpler version Zoffany painted for Asaf. Hastings is not in the picture although his diary records that he was present at **Mordaunt's cock fight of 5 April 1784**. Zoffany arrived in Lucknow to work for him on 3 June and was paid 15,000 rupees (about £1,500). The painting was finished after Hastings's return to England and was despatched to him in February 1788. At one time the picture was thought to have been lost at sea, and this a copy made by Zoffany, but this is now generally discounted.

Asaf's court at Lucknow was the most extravagant of the native courts attracting numerous European adventurers lured by the financial prospects and exotic lifestyle. Faiz Bakhsh wrote that Asaf's 'natural inclinations and attachments were for low, ill-born and base-minded associates ... He delighted in meaningless amusements and was immensely pleased with anyone who indulged in filthy language; and the more obscene the conversation was in any company, the better he was pleased' (quoted in Archer, p.143).

The **illiterate Mordaunt** was a particular favourite. An **illegitimate son of the Earl of Peterborough**, he was commander of the Nawab's bodyguard and leader of court amusements, including the cock-fights. At Lucknow, Indians and Europeans enjoyed social equality and personal friendship. Many Europeans had **Indian wives, or bibis**, and children.

The central figures of the Lucknow court are portrayed here: Colonel **Antoine Polier** in a red coat, standing under the awning, a Swiss officer who was engineer to the Nawab and possessor of several bibis and a number of children; **John Wombwell** seated to the right holding a hookah, the East India Company's paymaster at Lucknow; and below them in uniform, seated on the dais the French adventurer **Claud Martin**.

The notorious Martin kept four wives and was, among other things, the only man ever known to have successfully performed a surgical operation on himself. **Lord Valentia** wrote in an account after Martin's death: 'a more infamous or despicable character ... never existed. He had not a single virtue, though he laboured to assume the appearance of several' (quoted in Philip Davies, *Splendours of the Raj*, London 1985, pp.93-4). Standing beside Wombwell is the artist **Ozias Humphrey** with a hand on Zoffany's shoulder.

Standing at the far right corner, wearing a blue coat and holding a white bird, is **Robert Gregory, the assistant to the Governor-General's representative**. **Gregory was reportedly cut out of his father's will for cock-fighting**.

The rotund European in white sitting in the right foreground with a fighting-cock, is **Lieutenant Golding** of the East India Company's Corps of Engineers.

After its acquisition by the Tate the painting was cleaned, revealing new subtleties of colour, detail and meaning. The Nawab's state of sexual arousal, his agitated pose and inclination towards his chief minister and favourite bodyguard Hassan Resa Khan in the ornate red turban) add an erotic dimension to the nature of the cock fight. The vignette just behind the Nawab shows a bearded Hindu in turban fondling a Moslem boy catamite in the white cap worn by Moslem men, to the outrage of the man in the red turban who must be restrained by a courtier. Lewis Ferdinand Smith recounted that the Nawab 'has many adopted children, but none of his own' - despite a harem of 500 beauties - and that towards his wife of sixteen years 'he has never fulfilled the duties of a husband' (quoted in Archer, p.144). This painting was perhaps Hastings's select joke, a memento of his time in India.
