Purchase of an Ensigncy

Whereas by a settlement made at or before the intermarriage of **John Lyons Esq of Ladiston** and **Caroline Degennes** a certain sum was provided to be raised of the estate and then settled on the eldest son of said marriage at the death of said John Lyons and the sum so provided for the younger children of said marriage was to be equally divided between such younger children when they attained the full age of 21 years after the death of the said John Lyons or by his appointment in his lifetime after they arrived at the age of 21 years and

Whereas the waiting till the death of the said John Lyons and the arrival of each child to the full age of 21 years would be attended with great inconvenience to such of the younger children of said marriage as were capable of entering into any profession and **John Robert Lyons second son to said John Lyons** being desirous of buying a commission, I have advanced the sum of \$400 English money and have laid out the same in the purchase of an Ensigncy in the 69th Regiment of Foot

and the said **John Robert Lyons** being sensible of the advantage it is to him to be put early into the Army, Doth by these presents! acknowledge to have received the same and doth solemnly promise when he comes of age, or as soon as he is capable in law to Exonerate the Estate of so much out of his proportion of the sum he is entitled to receive by virtue of the marriage settlement aforesaid, and to give such discharge to his father if living and to his elder brother if his father shall be dead at the time,

and he also by these presents Doth promise that in case he comes eldest son and heir to the said settled estate at the death of his father or before his now elder brother should arrive at the full age of 21 years or should die without Docketing the Entail,

so that the said **John Robert Lyons** should be entitled to the Enjoyment of the said estate to pay back to the then younger children of the said marriage the sum of \$400 English to be equally divided between said younger children but withstanding liable to to any interest on the said sum of \$400 till the same become payable

1785 Indenture between John Lyons and his 2nd son, John Robert Lyons

Whereas by a settlement made at or before the intermarriage of **John Lyons Esq of Ladiston and Caroline Degennes**, a certain sum was provided to be raised of the estates then settled on the eldest son of said marriage at the death of said John Lyons, and the sum so provided for the younger children of said marriage was to be equally divided between such younger children when they attained the full age of twenty one years after the death of the said John Lyons, or by his appointment in his life time after they arrived at the age of twenty one years.

And whereas the waiting till the death of the said John Lyons and the arrival of each child to the full age of twenty one years would be attended with great inconvenience to such of the younger children of the said marriage as were capable of entering into any profession and **John Robert Lyons, second son to said John Lyons being desirous of buying a commission**, I have advanced the sum of £400 English money and have laid out the same in the purchase of an ensigncy in the **Sixty Ninth Regiment of foot**.

And the said **John Robt. Lyons** being sensible of the advantage it is to him to be put early into the Army, doth by these presents acknowledge to have received the same and doth solemnly promise when he comes of age, or as soon as his is capable in law to exonerate the estate of so much out of his proportion of the sum he is intitled to receive by virtue of the marriage settlement afforesaid, and to give such discharge to his father if living and to his elder brother if his father should be dead at the time, and he also by these presents doth promise that in case he comes eldest son and heir to the said settled estate at the death of his father or before his now elder brother should arrive at the full age of twenty one years or should die without docking the Entail, so that the said **John Robt. Lyons** should be entitled to the enjoyment of the said estate to pay back to the then younger children of the said marriage the sum of £400 English to be equally divided between said younger children but without being liable to any interest on the said sum of £400 till the same became payable.

Deed between Francis Savage and James Auchmuty**Dated 20th May 1742**
